

Statewide Survey of Likely General Election Voters in Oregon

Topline Report - February 13, 2017

Clout Research conducted a statewide telephone survey of likely general election voters in Oregon from February 10-12, 2017. The hybrid survey included 682 responses reached from landline and mobile telephones, and it carries a confidence interval of 95% and a margin of error of +/- 3.75%.

Q. During her campaign for Governor, Kate Brown accepted a \$250,000 contribution from gun-control activist Michael Bloomberg. After winning the election, Governor Brown issued a statewide ban that prohibits lawful concealed handgun licenses holders from carrying a gun in state-owned buildings. Do you believe the \$250,000 contribution influenced Governor Brown's decision to implement a ban on lawful gun license holders?

Q. The Oregon legislature recently passed an increased minimum wage and mandatory paid sick leave for employees. Local counties have sued the state, calling these policies unfunded mandates, and non-profits like Head Start have reported not having enough money in their operating budgets to follow the law without cutting services.
